

### Chapter Summary

This chapter focuses on a specific feature of Ælfric's style: the range of epithets and modifiers which he uses to describe those who persecute Christianity. When translating from the Latin, Ælfric generally abbreviates his sources, but in this chapter he is consistently less parsimonious with words. Indeed, the variety of additions used to qualify those who follow God's

a recurrent pattern throughout Ælfric's works but is ubiquitous in his narrative pieces. Some time ago, in a magister Aldhelm's style, Michael Winterbottom showed that many of the bishop's decorative features in the *De laudibus virginitate* were employed to appeal to the emotions of the audience, exploiting an important rhetorical device referred to as pseudo-Ciceronian *Ad C. Herennium de ratione dicendi*.
